**NATIONAL ENERGY RETAIL LAW (TASMANIA)

1. Short title

These regulations may be cited as the *National Energy Retail Law (Tasmania) Amendment Regulations 2013*.

2. Commencement

These regulations take effect on the day on which their making is notified in the *Gazette*.

3. Principal Regulations

In these regulations, the *National Energy Retail Law (Tasmania) Regulations 2012** are referred to as the Principal Regulations.

4. Regulation 9 amended (Price comparator)

Regulation 9(1) of the Principal Regulations is amended by omitting “, but only in relation to contestable customers within the meaning of the *Electricity Supply Industry Act 1995*”.

5. Regulation 10 amended (Modification of National Energy Retail Rules in relation to small market offer customers)

Regulation 10 of the Principal Regulations is amended by omitting subregulations (2), (3) and (4) and substituting the following subregulations:

- (2) Rule 6 of the National Energy Retail Rules is modified by omitting paragraph (c).
- (3) Rule 9 of the National Energy Retail Rules is modified by omitting paragraph (b) from subrule (2)(b).
- (4) Rule 10 of the National Energy Retail Rules is modified by omitting from

subrule (1) “ or as not a small market
offer customer”.”
